EDITORIAL

This issue of Behavior Research Methods & Instrumentation reports on the 10th National Conference on the Use of On-Line Computers in Psychology, held at the Chase Park Plaza Hotel, St. Louis, Missouri.

The 1-day conference was composed of 15 sessions. The morning sessions consisted of major addresses by Kristina Hooper, Michael Williams, and N. John Castellan, Jr. The afternoon and evening sessions were dedicated to contributed paper sessions, symposia, and users' group meetings (Digital Equipment Corporation and microprocessors). The Program Committee members were: Doris Aaronson, New York University; Russell Church, Brown University; Howard Kaplan, Addiction Research Foundation of Ontario; Alan Lesgold, University of Pittsburgh; Dominic Massaro, University of Wisconsin at Madison, Chairman; Misha Pavel, New York University; and Walter Schneider, University of Illinois at Urbana. The Exhibits Chairman was Richard Parker, University of California at Santa Barbara.

Conference officers for 1980-1981 are: John W. Cotton, University of California at Santa Barbara, President; Russell Church, Brown University, President-Elect; and Cynthia Null, College of William and Mary, Secretary-Treasurer. Newly elected Steering Committee members are: Doris Aaronson, New York University; H. Kaplan, Addiction Research Foundation of Ontario; and G. Loftus, University of Washington.

The 11th National Conference on the Use of On-Line Computers in Psychology will meet in Philadelphia, Pennsylvania. The conference meets 1 day before the meetings of the Psychonomic Society, which will be held in the same city.

Membership in the group and participation in the meetings is not limited to psychologists.
